#### FROM THE EDI CORNER.....

Blue Cross/Blue Shield of Massachusetts has one million members. They are going to have an Internet World-Wide Web server, as well as on-site multimedia kiosks equipped with modem connections to the insurance carriers' customer-service operations.

Blue Cross plans to allow hospitals and physicians to automatically file claims and insurance information on-line. Future services also could include providing users with instant updates on claims being processed and other member information.

How is this different from other carriers? There are no long distance charges for the Internet. Many Internet access providers offer unlimited access for a low, fixed monthly charge. Some of our larger groups may be able to save a lot of money by using the Internet instead of calling long-distance or joining a service like Compuserve.

There are, of course, some potential problems. When you transmit over the Internet, your files are broken up into many small pieces called "packets". Some of the present Internet software packages cannot put these pieces back together properly. Your files can get scrambled.•

#### COMPUTERIZED PATIENT RECORD

We have had requests over the years for a way to scan the patient chart into the computer so it could be rapidly accessed without having a person look for it. It seems like it should be easy to get a \$1000 scanner and begin scanning your charts. Unfortunately there is a lot of labor in the scanning process. You can fill a 1 gigabyte hard disk very quickly. You cannot recall a scanned image unless you give it a meaningful file name. How long to you want to keep information? Many doctors think that the most valuable information is the past exam. If a 58 year old male appears at the emergency room with chest pain, how valuable is it to have information from a previous routine check up? Should you keep pediatric charts for 20 years for litigation purposes? The problem at this time is the cost of storage and maintenance of a very large database. For example, a group of primary



care doctors or a 350 bed hospital can generate 1.7 million pages of medical records each year. One scanned page requires 50,000 bytes of storage. To keep records on-line for 3 years would require as much as 220 gigabytes of storage. This storage does not include diagnostic images, correspondence, and other necessary documentation. This is still too expensive for most organizations but the price is dropping daily.

We have attended meetings which were focused on imaging techniques. Most people in that field think in terms of keeping records for tax purposes and related reasons. Five years is considered a long time to keep the records on line. This may not be acceptable for medical records.

There are people who are trying to design a

standard coding structure for records medical for all specialties. If data can be coded it takes much less storage. Coded data can be used for searching and reporting much easier than free text or scanned images.•


are looking at ways to extend the hours.

#### ADVANCED TIP OF THE MONTH

If a civilian provider's services are rendered at a Military Treatment Facility (MTF) as part of a "resource sharing" program do the following:

In addition to identifying the place of service as '26', the provider is required to identify the services as being rendered pursuant to a Resource Sharing Agreement. This is done by adding a three digit extension to the tax ID number.

Setup a new insurance record for Champus with the MTF number following the insurance company name. For example, if the treatment facility number is 027 you would create an insurance record with the following name:

CHAMPUS CLAIMS (MTF:027)
