CFA has announced that there will not be any ICD-9 code changes for next year, which begins October 1, 1999.

The reference for this is the Federal Register May 7th, page 24741- section 8.

We have been told that there are conferences being given in various locations by consultants who are distributing examples of new codes.

The ICD-9 codes are the responsibility of a Federal interdepartmental committee named National Center for Health Statistics (NCHS) and HCFA. The NCHS has the lead responsibility for the ICD-9-CM diagnosis codes and HCFA has the lead responsibility for the ICD-9-CM procedure codes. This committee did hold public meetings and they did consider approval of coding changes for Fiscal Year 2000 at public meetings. They decided not to implement any changes for FY 2000. The reason is that they must make a major effort to ensure that all of the Medicare computer systems are ready to function on January 1, 2000. The code changes were postponed until FY 2001 which begins October 1, 2000.

This is especially important because it may postpone the introduction of a new coding structure: ICD-10 -CM codes. These codes have more characters than the current ICD-9-CM codes and are not supported by most computer software now being used by Healthcare providers and payers.

Most people know they must be able include the century in their dates. They must also be sure they can use the new ICD-10-CM codes. The codes will be required sometime in the next 2-5 years.

We have already designed a database modification which will expand the current diagnosis field that is kept in the transaction file and also in the diagnosis lookup file. This modification, like all other database upgrades will occur with an ordinary update and no user intervention will be required. If a conversion lookup table is made available by HCFA, we plan to include it with the update.

We are not promising a definite date at this time, but a beta of our new Windows program will probably be available for Internet download this summer. If you are interested, please send an email. •

#### DATABASE SALES

Oracle surpassed IBM in sales of database products in 1997 to become the number one supplier. Recently, CNET reported that IBM has surpassed Oracle in sales of its database product DB2. IBM now has 32.3% of the market, Oracle has less than 29.4% and Microsoft has 10.2% with its database product SQL server. Informix has 4.4% share and Sybase has 3.5% of the database software market.

A Dataquest report states that the database software market will grow to \$10 billion by 2003. •

## SOFTWARE SUPPORT NOTES


- 1 Faxed requests for support get <u>Priority Service</u>.
- 2 If you send a fax with a description of the problem, your call is given priority over other faxes.
- 3 Do not call more than one time. The second call places your first call at the bottom of our callback list.

We can receive many calls in the first few hours each day. It usually is not possible for us to have a technical support person waiting to take your call. If you just call and leave the message "please call", your call is placed at the bottom of the callback list. We must do everything we can to avoid "phone-tag". Hand-written faxes can be almost impossible to read, so please type them whenever possible. Include the best time to call you.

At this time we can deliver support by email. If you check your email each day, you may find this to be easier than faxing us. This is not very good support if you need a quick answer. We do not get very many support email messages so we only check the mail two or three times each day. As the volume increases, we will put more resources into email.
